ARTICLES OF ORGANIZATION
FOR

(A Florida limited liability company)

Pursuant to 608.407, Florida Statutes, these Articles of Organization of RILEY L. YARBOROUGH, LLC, a Florida limited liability company (hereinafter referred to as the "Company") are filed on this the 26 day of October 2007, for the purpose of forming a limited liability company under the laws of the State of Florida, and executed by Riley L. Yarbrough an authorized representative of the Company, pursuant to the Florida Limited Liability Company Act (hereinafter referred to the "Act").

ARTICLE I - Name.

Unless earlier termination under the act of the Operating Agreement the period of duration of the Company shall be perpetual.


ARTICLE III - Address of Place of Business.





Article VI - Dissolution.
