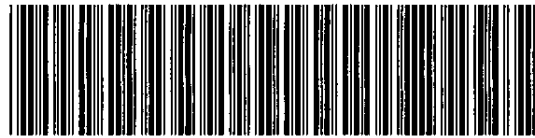

VII.

Purpose

The purpose of this company shall be:

1. The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the member.
2. Maintain a youth symphony in Marion County, Florida for the use and benefit of the youth of Marion County, Florida, to provide musical training to the youth and opportunities to perform.

3. To provide monetary or other assistance to the youth who have a desire to learn and excel in playing musical instruments who may not be able to pay part or all of the costs of instruments, training and music.

4. The Company is organized exclusively for charitable and educational purposes consistent with §501(c)(3) of the Internal Revenue Code.

VIII.

The Company is intended to be treated as a branch of its Members for federal and state income tax purposes, except as otherwise required under applicable law. The Company shall take such actions including the making of available tax elections, as are reasonably necessary to insure the Company will be so classified.

This Company is established for the exclusive benefit of the Company, its Members and its successors and assigns. This Company is expressly not intended for the benefit of any creditor of the Company or any other person. Except and only to the extent provided by applicable statute, no such creditor or third party shall have any rights under or against this Company or any agreement between the Company and any Member with respect to any contribution or otherwise.

IX.

In the event of the dissolution of this Company, the residual assets of the organization shall be turned over to the First Christian Church of Ocala, Florida, or its successors in interest. In the event The First Christian Church or its successor or successors are no longer in existence, then the residual assets of such organization shall be distributed to the Marion County Board of Education of Marion County, Florida. In the event the Marion County Board of Education or its successor or assigns is no longer in existence, then to such organization or organizations which themselves are exempt as organizations described in §501(c)(3) and 170(c)(2) of the present Internal Revenue Code or as the same may be amended from time to time, or corresponding


