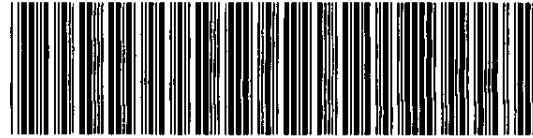



1. The name of the Limited Liability Company is:

THE OCALA YOUTH SYMPHONY, LLC

2. The Articles of Organization were filed by the Company on October 31, 2007.

3. The following is the amendment to the Articles of Organization:

Article VII of the Articles of Organization is amended by adding Paragraph 5 thereof as follows:


A. All income for each taxable year of the company shall be distributed at such time and in such manner as not to subject the foundation to tax under IRS Code Section 4942, and

B. To prohibit the company from engaging in any act of self-dealing (as defined in Section 4941(d)), from retaining any excess business holdings (as defined in Section 4943(c)) from making any investments in such manner as to subject the company to tax under Section 4944, and from making any taxable expenditures (as defined in Section 4945(d)).
