



ARTICLES OF ORGANIZATION OF



The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is AK CONSULTING GROUP OF AMERICA, LLC (hereinafter referred to as the "Company").

2. PERIOD OF DURATION.
