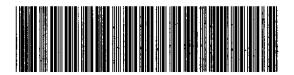

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF AK CONSULTING GROUP OF AMERICA, LLC

The undersigned, pursuant to the provisions of Chapter 608.411 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of amending and restating the Articles of Organization previously filed do set forth the following:

1. NAME.

The name of the Limited Liability Company is **AK CONSULTING GROUP OF AMERICA**, **LLC** (hereinafter referred to as the "Company").

2. **PERIOD OF DURATION**.

The period of duration of the Company shall be perpetual, unless it is dissolved as provided in the Florida Limited Liability Act or the written Operating Agreement to be executed by all of the Members of the Company.

3. PURPOSE.

To engage in any and all other businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

4. ADDRESS OF PLACE OF BUSINESS.

The address of the place of business in Florida for the Company is: <u>7719 PRESERVATION ROAD</u>, <u>TALLAHASSEE</u>, <u>FLORIDA 32312</u>. Such address may be changed from time to time as provided in the Operating Agreement.

5. REGISTERED AGENT AND REGISTERED OFFICE.

The initial registered agent in Florida for the Company is: <u>DANIEL E. MANAUSA</u> and the initial, registered office is 3520 Thomasville Road, 4th Floor, Tallahassee, Florida, 32309.

6. ADDITIONAL MEMBERS.

The Company shall have <u>one (1) member</u>, and may admit additional members upon the approval of the sole member, or as otherwise provided in the Operating Agreement.

7. **CONTINUITY OF BUSINESS.**

Upon the death, retirement, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other even which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the

Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

8. MANAGEMENT.
