**ARTICLES OF DISSOLUTION
OF

TRILOGY COMMERCIAL LENDING, LLC, a Florida limited liability company (the "Company"), pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Dissolution:

**ARTICLE I
NAME**

The name of the Company is **TRILOGY COMMERCIAL LENDING, LLC**.

**ARTICLE II
EFFECTIVE DATE**

The effective date of these Articles of Dissolution shall be the date of filing of the Articles with the Department of State.

**ARTICLE III
ELECTION TO DISSOLVE**

Pursuant to the Operating Agreement of the Company, the members of the Company holding at least a Supermajority of the Membership Units (as required by and defined in the Operating Agreement) elected to dissolve the Company by written consent dated effective of December 31, 2014.

**ARTICLE V
DISTRIBUTION OF PROPERTY**

All of the remaining property and assets of the Company shall be distributed to the members of the Company in accordance with their respective rights and interests as reflected in the Operating Agreement of the Company.

NO SUITS**

To the knowledge of the members of the Company, there are no suits pending against the Company in any court.
