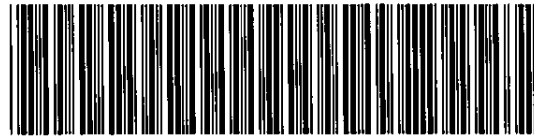

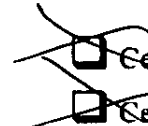

NISHPICKEL, LLC is to be managed by a manager and the name and address of the individual who will serve as the manager is:

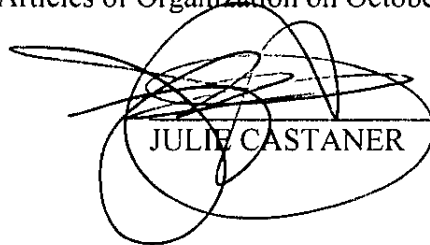

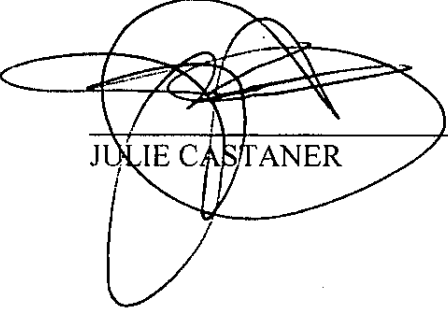
