ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY OF

HERITAGE CLASSIC CARS, L.L.C.

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), form a Florida limited liability company (this "Company") pursuant to the Act and set forth the following Articles of Organization (these "Articles"):

ARTICLE I - NAME

The name of this Company will be:

ARTICLE II - COMMENCMENT DATE AND DURATION

This Company will commence on November 15, 2007, in accordance with the provisions of Section 608.409(1) of the Act, and will continue for a period of 50 years from the commencement date, or until dissolved by its members in accordance with Section 608.441 of the Act or the provisions of these Articles.
