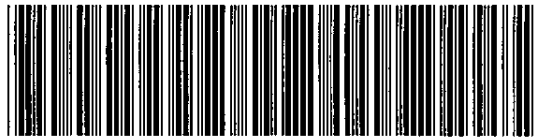

ARTICLES OF ORGANIZATION

EBC of Charlotte Co., LLC

(Pursuant to s. 607.407, Florida Statutes)

1. **Name.** The name of the limited liability company is EBC of Charlotte Co., LLC.
