ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED, CHAIM J. MARGOLIN, for the purpose of forming a professional limited liability company under the Florida Statutes Chapters 608 and 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

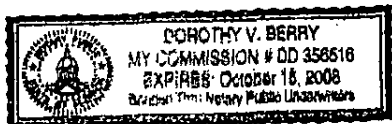
