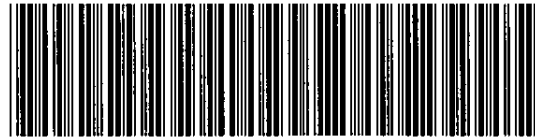



This limited liability company shall exist perpetually, commencing on November 1, 2007.


