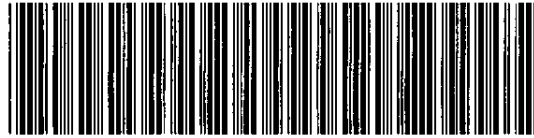

**ARTICLES OF AMENDMENT OF  
ARTICLES OF ORGANIZATION

The undersigned members, acting pursuant to §608.4231, Florida Statutes, as amended, hereby adopts the following Articles of Amendment of Articles of Organization (these "**Articles of Amendment**").

1. **COMPANY NAME.** The current name of the Company has been and is Skinner TSA, LLC".
2. **DATE OF FILING OF THE ARTICLES OF ORGANIZATION.** The articles of organization were filed on November 6, 2007.
3. **AMENDMENTS ADOPTED.** This Amendment provides for the Company's change of name. The text of the amendment is as stated below.

Article II of the Articles of Organization is hereby deleted in its entirety and the following Article II shall be substituted in for Article II:


**ARTICLE II**

## CERTIFICATE OF DESIGNATION AND ACCEPTANCE REGISTERED AGENT


