ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF WALDEMERE VENTURES, LLC

Pursuant to Florida Statutes § 608.411, the Articles of Organization of WALDEMERE VENTURES, LLC filed on November 6, 2007, and assigned Document Number L07000112603, are hereby amended as follows:

Article IV of the Articles of Organization is hereby deleted in its entirety and replaced with the following new Article IV:

ARTICLE IV. MANAGEMENT

The Company shall be managed by two (2) managers (who shall be designated as "Managers") and is, therefore, a manager-managed limited liability company. The initial Managers are:

The rights, duties, obligations and authority of the Managers shall be set forth in the Operating Agreement of the Company. Other than the filing of these Articles, no person, other than the Managers, is authorized to execute documents to be filed with the Florida Department of State or to otherwise bind or transact business on behalf of the Company.
