



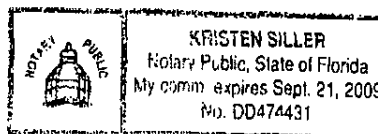

**ARTICLES OF ORGANIZATION
OF
INVESTORS ASSOCIATES OF FLORIDA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: INVESTORS ASSOCIATES OF FLORIDA, LLC.

ARTICLE II -- ADDRESS

The street address of the principal office and mailing address of this company is 51 Camelot Gardens, Apartment 205, Lehigh Acres, Florida 33970.

ARTICLE III -- DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date, if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE VI -- ADMISSION OF NEW MEMBERS



ARTICLE VII -- RESIDENT AGENT ACCEPTANCE




