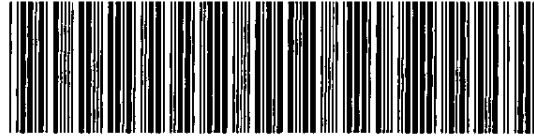

## **ARTICLES OF ORGANIZATION**

**OF**

### **SMOKIN' PINES TIMBER AND LAND COMPANY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE I - NAME**

The name of the limited liability company shall be **SMOKIN' PINES TIMBER AND LAND COMPANY, LLC** ("Company").

#### **ARTICLE II - ADDRESS**
