**ARTICLES OF ORGANIZATION OF
3135 HADDAM, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be 3135 HADDAM, LLC ("Company"), the principal place of business of the Company in Florida shall be 3034 Hawks Glen, Tallahassee, Florida 32312. The mailing address shall be the same.

**ARTICLE II
DURATION**

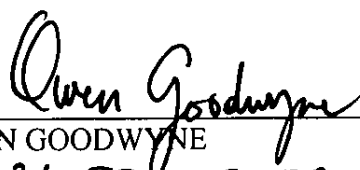
