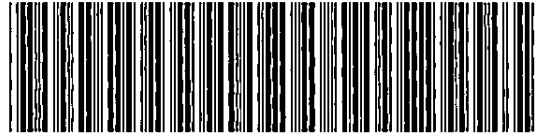

ARTICLE I  
Name

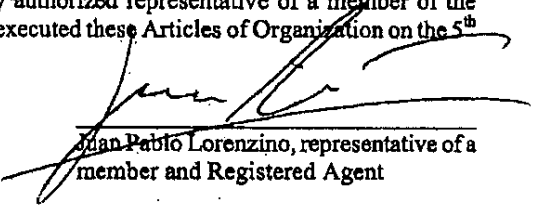
ARTICLE III
