ARTICLES OF ORGANIZATION OF
PUBLIC PURPOSE CONSULTING, LLC

ARTICLE I
NAME

The name of the limited liability company shall be Public Purpose Consulting, LLC.

ARTICLE II
PURPOSES AND POWERS

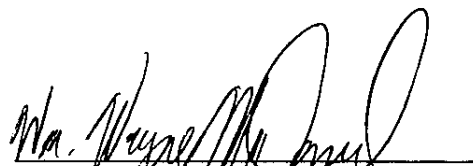
A Member's interest in the limited liability company may not be sold or otherwise transferred except as provided in the Operating Agreement adopted by the Members.
