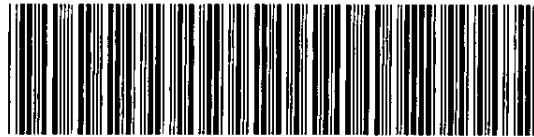

REGISTERED OFFICE AND AGENT


