ARTICLE 1 - NAME

ARTICLE 12 - REGISTERED OFFICE AND REGISTERED AGENT

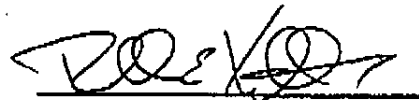
The initial registered agent for the Company shall be Rodd Everett Kelley, whose address shall be 3401 East 7th Avenue, Tampa, Florida 33605.
