#### ARTICLES OF ORGANIZATION

# C & R EQUIPMENT OF JACKSONVILLE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

#### NAME

The name of the limited liability company shall be C & R Equipment of Jackson le, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 537 Lane Avenue North, Jacksonville, Florida 32254.

#### ARTICLE II

#### **PURPOSES AND POWERS**
