**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
C & R EQUIPMENT OF JACKSONVILLE, LLC**

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is C & R Equipment of Jacksonville, LLC (the "Company").
2. The date of filing of the Articles of Organization of the Company was November 9, 2007.
3. That Article VI of the Articles of Organization of the Company is hereby amended and replaced in its entirety to read as follows:

**ARTICLE VI**
