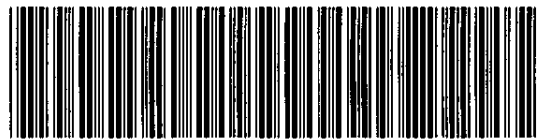

The above referenced limited liability company has been dissolved upon the written Consent of the sole Member of the limited liability company pursuant to Section 608.441 of the Florida Statutes.


5. All debts, obligations and liabilities of the limited liability company have been paid or discharged.


