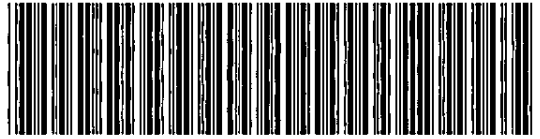


CERTIFICATE DESIGNATING REGISTERED AGENT
