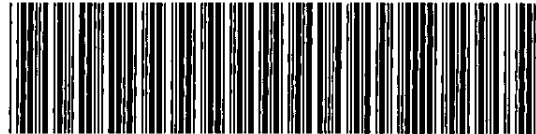

Article III - Duration

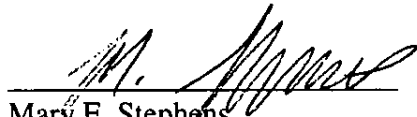

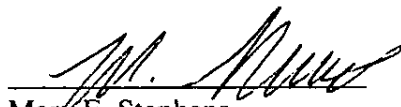
