The name of the limited liability company is: CF Acquisition, LLC.

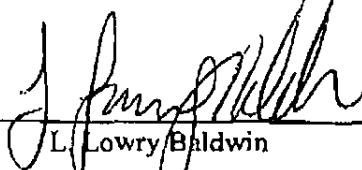

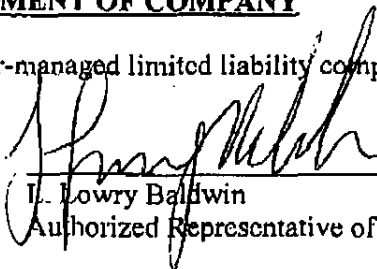
