**ARTICLES OF ORGANIZATION OF
TRAFFICOP, LLC**

Article I

The name of the limited liability company ("Company") is TRAFFICOP, LLC.

Article II

The mailing address of the Company is 2173 S. Woodland Boulevard, DeLand, Florida 32720 and street address of the Company's principal office is 2173 S. Woodland Boulevard, DeLand, Florida 32720. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.


Article VII
