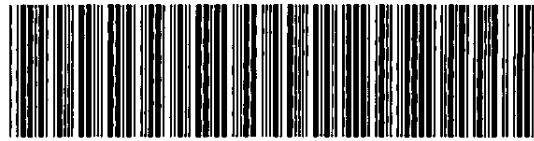

Article I - Name


