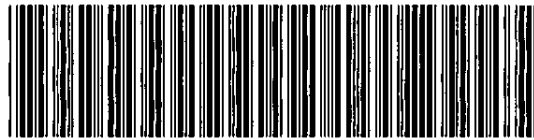

TERM
