**ARTICLES OF ORGANIZATION  
OF  
UNIVERSITY OF MIAMI PRESERVATION, LLC  
a Florida limited liability company**

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of the limited liability company is UNIVERSITY OF MIAMI PRESERVATION, LLC (the "Company").

ARTICLE II - ADDRESS

The period of duration of the Company shall be perpetual.

ARTICLE IV - PURPOSES

The purpose for which the Company is organized is to be the beneficiary of a Conservation Easement to be granted by the University of Miami to the Company and to be recorded in the Public Records of Miami-Dade County, Florida (the "Conservation Easement") for those certain conservation areas located on the property known as Smathers Four Fillies Farm, according to the Plat thereof, as recorded at Plat Book 165, Page 33, of the Public Records of Miami-Dade County, Florida, or any other action necessary or required in accordance with the terms, provisions, restrictions and conditions contained in the Conservation Easement.




