**ARTICLES OF ORGANIZATION
OF
HANNAH JOHNSON, LLC**

**ARTICLE I
NAME**

The name of the limited liability company (hereinafter referred to as the "Company") is HANNAH JOHNSON, LLC.

**ARTICLE II
ADDRESS**

The mailing address of the Company's principal office is P.O. Box 427, Plymouth, Florida 32768 and the street address is 1230 Dekleva Drive, Apopka, Florida 32712.

**ARTICLE III
DURATION**

The duration of the Company shall be perpetual, beginning on the date these Articles of Organization are filed with the Florida Department of State.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

The name of the Company's initial registered agent in Florida is: David C. Brennan, and the address of the Company's registered office in Florida is: 1214 E. Robinson Street, Orlando, Florida 32801.

**ARTICLE V
MANAGEMENT**

The Company is to be managed by one or more members designated as managers. Each initial managing member is identified as follows:

ARTICLE VI
ADMISSION OF NEW MEMBERS

Members of the company have the right to admit new members. Additional members may be admitted on the unanimous written consent of the existing members. Existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.

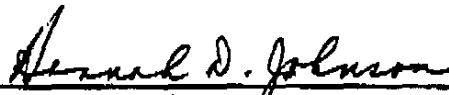
ARTICLE VII
CONTINUATION OF BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be so continued only on the unanimous written consent of the remaining members.

ARTICLE VIII
REGULATIONS

The power to adopt, alter, amend or repeal these Articles of Organization; any operating agreement or other regulations of the Company is vested entirely in the members of the Company.

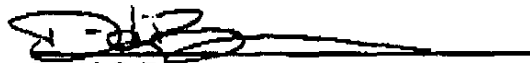
