ARTICLES OF ORGANIZATION

OF

BBC BAY SIDE RESORT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Chapter 608 of the Florida Statutes), hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of this limited liability company is BBC Bay Side Resort, LLC (the "company").

ARTICLE II -- ADDRESS

The company's mailing address shall initially be 1710 Gulf Drive North, Unit E, Bradenton Beach, FL 34217 and the street address of the company's principal office shall initially be the same.
