

**THESE ARTICLES OF ORGANIZATION** are made this 13<sup>th</sup> day of November, 2007.

The undersigned, an authorized agent of the one person desiring to organize a limited liability company under and pursuant to the provisions of the Florida Limited Liability Company Act (Sections 608.401-608.705) of the Annotated Code of Florida) (hereinafter referred to as the "**Act**"), hereby organizes a limited liability company (the "**Company**") for the purposes and on the terms and conditions hereinafter set forth and hereby certifies to the Division of Corporations of the Florida Department of State as follows:
