The undersigned, HEALTH FIRST NETWORK, INC., and FIPA REGION #3, INC. d/b/a Physicians' Care Network, entities authorized to contract and members of Patient Care First Network, LLC, hereby present these Articles of Organization as the Articles of Organization of Patient Care First Network, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

Patient Care First Network, LLC

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing and street address of the principal office of the Company is 5024 NW 27th Court, Suite A, Gainesville, Florida 32606.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for the purpose of acting as an Independent Physicians' Association for the rendering of medical services to managed care organizations and conducting such other business as the Members of the Company shall determine pursuant to applicable law, and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.
