ARTICLES OF ORGANIZATION

OF

2633 SOUTH PONTE VEDRA BLVD, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, does hereby adopt the following Articles of Organization.

ARTICLE 1.0

The name of the Limited Liability Company shall be 2633 South Ponte Vedra Blvd, LLC.

The period of its duration may not exceed 40 years from the date of filing Department of State.
