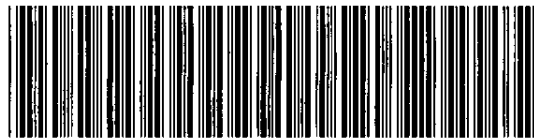

ARTICLES OF ORGANIZATION
OF
WEEKS FAMILY PROPERTIES - 136, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, does hereby adopt the following articles of organization:

ARTICLE I - NAME
