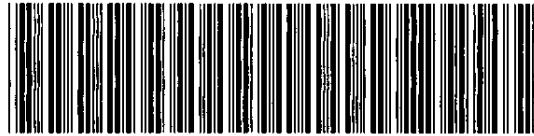

**NAME**

**2. PERIOD OF DURATION**

**This limited liability shall have perpetual existence.**

**3. PURPOSE**

**The purpose is to operate a real estate brokerage, developing commercial real estate properties and maintaining an office located at: 581 East S.R. 434, Suite 03, 2<sup>nd</sup> floor, Longwood, FL 32750 and to engage in such Other Business and activities as may be permitted by the laws of the State of Florida. **10. MANAGEMENT**

The business and affairs of the Limited Liability Company shall be managed and all decisions shall be made by a majority vote of the members, each member having one vote for each percentage point (or the appropriate fraction thereof) of "percentage ownership" in the Limited Liability Company. Notwithstanding the same, the execution of any instrument, including deeds, mortgages, Leases and other contracts, purporting: to be signed on behalf of the Limited Liability Company by any one (1) member shall, as to any third party relying thereon, be conclusively presumed to have been the authorized act of the Limited Liability Company, and shall, for all Purposes, bind it. 
