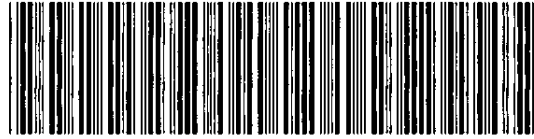


- A. The name of the limited liability company is ICON First Land Partners, LLC (the "Company").
- B. The Articles of Organization of the Company were filed with the Florida Secretary of State on November 19, 2007.
- C. The Articles of Organization are amended in part to read as follows:

"ARTICLE IV - MANAGERS"

The Company shall be managed by one or more managers and is, therefore, a manager-managed Company. The initial managers of the Company shall be Shyam B. Paryani, M.D. and John Wells, M.D. (collectively, the "Managers"). The Company may elect new or additional managers at the first meeting of its members. The Managers shall be elected, hold office and have the responsibilities set forth in the Operating Agreement of the Company."

- D. There are no other amendments to the Articles of Organization, except as stated above.
