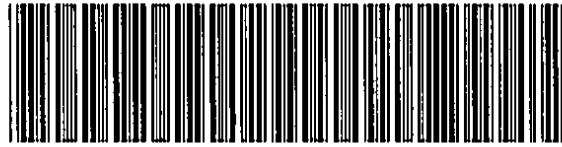



3. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin.


