TO
ARTICLES OF ORGANIZATION
OF**

Pursuant to Section 608.411 of the Florida Statutes, **JK Transport Distribution & Warehouse LLC**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Incorporation:

The Articles of Organization for the Company were filed on November 19, 2007 and assigned Florida Document Number L07000116506.

ARTICLE I

Name

The name of the Company is **JK Transport Distribution & Warehouse LLC**.

ARTICLE II

Amendments

Article I shall be amended to change the name of the Company to **Mercury Distribution & Logistics, LLC** and, therefore, the old Article I of the Company's Articles of Organization is hereby deleted and the new Article I is added and shall read as follows:

"ARTICLE I

Name

The name of the limited liability company is **Mercury Distribution & Logistics, LLC.**"

Article V shall be amended regarding the management of the Company and, therefore, the old Article V of the Company's Articles of Organization is hereby deleted and the new Article V is added and shall read as follows:

"ARTICLE V

Management

The management of the limited liability company, unless otherwise provided in the articles of organization or the operating agreement, shall be vested in a Board of Managers."

ARTICLE III

Date and Manner of Adoption

The foregoing Amendment was adopted by the managers and members of the Company by unanimous vote on May 5, 2009.
