ARTICLES OF ORGANIZATION

OF

EXPRESS HEALTHCARE SOLUTIONS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be EXPRESS HEALTHCARE SOLUTIONS LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 800 North Miami Avenue, #905, Miami, Florida 33136 and the mailing address shall be the same.

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
