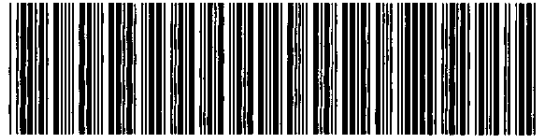

The name of the Florida limited liability company is **Wings Over Jacksonville, LLC**.


