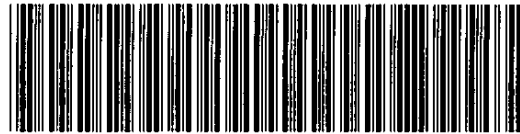


**ARTICLE VI – MANAGEMENT**
