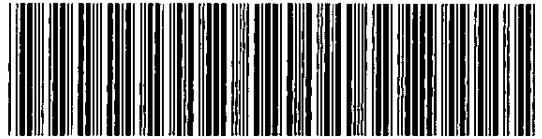

ARTICLE FOUR


The purpose or purposes for which the limited liability corporation is organized are


