The foregoing Amendment shall become effective and the Articles of Organization shall be deemed to be amended hereby upon the filing to these Articles of Amendment by the Department of State.


Article III is hereby amended to read as follows:

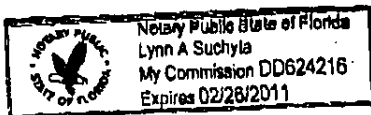
