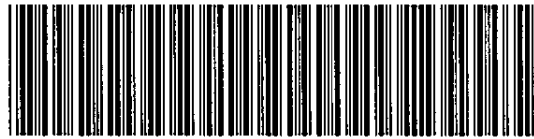

ARTICLES OF ORGANIZATION
OF
