ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
LONG RUNN INVESTMENT (ASIA PACIFIC), LLC

LONG RUNN INVESTMENT (ASIA PACIFIC), LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization as now in effect (the "Articles of Organization"), in accordance with the requirements of Section 608.411, Florida Statutes, does hereby certify as follows:

1. The name of the Company is LONG RUNN INVESTMENT (ASIA PACIFIC), LLC, and its Document Number with the Florida Department of State is L07000117603.
2. The Articles of Organization were filed with the Florida Department of State on November 21, 2007.
3. The Amendment to the Company's Articles of Organization being effected hereby was duly authorized and adopted by the sole Member and sole Manager of the Company by written consent on August 18, 2011.
4. These Articles of Amendment to the Company's Articles of Organization shall be effective immediately upon filing hereof with the Florida Department of State.
5. The Articles of Organization are hereby amended by deleting the provisions of Article III and Article V in their entirety and inserting the following in lieu thereof:

ARTICLE III

Business and Purpose

The general purpose for which the Company is organized is the transaction of any and all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act and any amendments thereto, including, but not limited to investing and consulting with respect to real estate, and in connection therewith, the Company shall have and may exercise any and all powers conferred from time to time by law upon limited liability companies formed under such Act.


