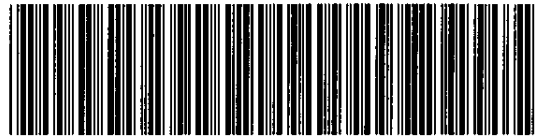

ARTICLES OF ORGANIZATION
OF
SOUTHERN TENNIS SUPPLIES, LLC

I.
Name

The name of the limited liability company is Southern Tennis Supplies, LLC (the "Company").

II.
Organizer

The organizer of the Company is Ted Michael Busby, and his address is 2142 Chatsworth Drive, Navarre, Florida 32566.

III.
Registered Office and Registered Agent

The street address of the Company's initial registered office is 2142 Chatsworth Drive, Navarre, Florida 32566, and the initial registered agent at that address is Ted Michael Busby.

IV.
Place of Business

The mailing address of the Company's principal place of business is 2142 Chatsworth Drive, Navarre, Florida 32566.

V.
Management

The management of the Company shall be vested in one or more managers, who shall be appointed by the members pursuant to the Operating Agreement and who shall have the right to control and manage the Company as provided in the Operating Agreement. The members shall not take part in the management and control of the Company and shall have no power to bind the Company, except as otherwise provided in the Operating Agreement.

VI.
Indemnification

(a) The company shall indemnify every manager, and the manager's heirs, executors and administrators, against expenses actually and reasonably incurred by the manager, as well as against any amount paid upon a judgment in connection with any action, suit, or other

proceeding, civil or criminal, to which the manager may be made a party by reason of having been a manager of the Company. This indemnification is not exclusive of other rights to which the manager(s) may be entitled. The manager(s) are entitled to the fullest indemnification allowed by law, as may be amended from time to time after the adoption of these articles.

(b) A manager shall be liable to the company for the following actions: (i) any breach of his or her duty of loyalty to the company, or to its members; (ii) an act or omission that was not taken in good faith, fair dealing or in the best interests of the Company, as provided in Section 608.4225 of the Florida Statutes as amended; (iii) a transaction in which the manager benefits to the detriment of the company or its members; or (iv) an action for which the manager is liable at law and for which an indemnification is not allowed.
