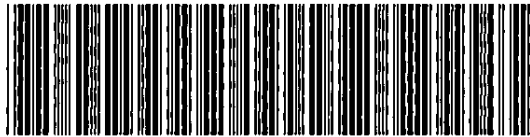

ARTICLE I:


