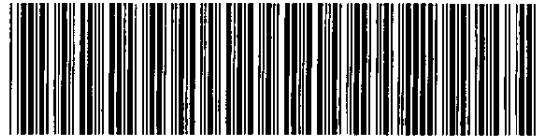

ARTICLE IX - ADDITIONAL PROVISIONS


